Do you have document on file to use the following logos: NIKE, Nissan, UPS, etc. It's not enough to have verbal permission, you need a letter from companies on file granting you permission. The same holds true for the Frog and MADD. I am not certain about using videos and music on Internet sites; the corporate lawyer can advise.*** If this is a problem, we can create our own videos and music. I already have ideas of how to use XXXX and XXX.

Let's just take a deep breath, take corrective action, do damage control and move forward. God works in mysterious ways; you were considering changing the xtagged name anyways.
