ROMAN HENTISH, being duly sworn upon an oath deposes and says that: He is a Probation Officer for the Utah State Department of Corrections; that on the 19th day of August, 2014, the above-named defendant was adjudged guilty of the crime of 2 Ct(s) SECURITIES FRAUD, THIRD DEGREE FELONY, in the above-entitled Court and on the 7th day of October, 2014, was sentenced to serve a term of 0 to 5 years in the Utah State Prison; that the execution of the imposed sentence was stayed and the defendant was placed on probation under the supervision of the Department of Corrections; that the above-entitled defendant did violate the terms and conditions of the defendant's probation as follows, to-wit:

- 1. By having failed to report as directed, on or about 05/13/2016, in violation of a standard condition of the Probation Agreement. PC-Defendant called AP&P on 05/10/2016, and scheduled an appointment to report to his probation agent on 05/12/2016. He failed to report as agreed. Defendant called again on 05/13/2016, and agreed to report that day since his missed his scheduled appointment the previous day. Defendant failed to report again and has not contacted or been cooperative with AP&P in any regard. Defendant refuses to report as required to maintain accountability and comply with his probation agreement.
- 2. By having failed to report as directed, on or about 04/07/2016, in violation of a standard condition of the Probation Agreement. PC-Defendant failed to report to his agent at the Salt Lake City office this date to maintain proper accountability. Defendant refused to report as directed and in non-compliant and unaccountable.
- 3. By having failed to report as directed, on or about 03/29/2016, in violation of a standard condition of the Probation Agreement. PC-Defendant met with his probation agent at court on 03/22/2016, and was instructed to report to his agent at the Salt Lake City office on 03/29/2016. Defendant failed to report as directed.

WHEREFORE, your affiant prays that an Order from the Court issue directing and requiring the above-named defendant to be and appear before said Court to show cause, if any he has, why the aforesaid period of probation should not be revoked, and why said defendant should not be forthwith committed to the Utah State Prison.
